- Having seen the Constitution of the Kingdom of Cambodia;
- Having seen Royal Decree No. NS/RKT/0918/925 dated 06 September 2018 on the Appointment of the Royal Government of Cambodia;
- Having seen Royal Code No. NS/RKM/0618/012 dated 28 June 2018 promulgating the Law on the Organization and Functioning of the Council of Ministers;
- Having seen Royal Code No. NS /RKM/0196/18 dated 24 January 1996 promulgating the Law on the Establishment of the Ministry of Economy and Finance;
- Having seen Royal Code No. NS/RKM/0707/017 dated 20 July 2007 promulgating the Law on Customs;
- Having seen Royal Code No. NS/RKM/0508/016 dated 13 May 2008 promulgating the Law on Public Financial System;
- Having seen Sub-Decree No. 488 ANKR.BK dated 16 October 2013 on the Organization and Functioning of the Ministry of Economy and Finance;
- Having seen Sub-Decree No. 75 ANKR.BK dated 25 May 2017 on the Adjustment of Sub-Decree No. 488 dated 16 October 2013 on the Organization and Functioning of the Ministry of Economy and Finance;
- Having seen Sub-Decree No. 82 ANKR.BK dated 16 November 1995 on General Regulations of Public Accounting;
- Having seen Sub-Decree No. 72 ANKR.BK dated 07 June 2018 on Non-Tax Revenue Management;
- Having seen Prakas No. 272 SHV.BRK dated 17 March 2011 of the Ministry of Economy and Finance on the Implementation of Payment Receipts;
- Having seen Circular No. 005 SHV dated 17 March 2011 of the Ministry of Economy and Finance on the Management of Payment Receipt;
- Pursuant to the necessity of the Ministry of Economy and Finance.

Hereby Decides:

Article 1: To permit the General Department of Customs and Excise of Cambodia to implement the collections of revenues from public service fees for the benefit of the national budget.

Public services provided by the General Department of Customs and Excise of Cambodia have been prepared as public service list detailing service fees, maximum service duration and the validity according to each public service, as stipulated in an annex table attached to this Prakas.

Article 2: The General Department of Customs and Excise of Cambodia shall publicly announce, especially at the service desk, the service standard including fee list, documents pertaining to the provision of public services.

The service desk shall set up a desk to obtain complaints, which could be accidentally filed, especially in case of breaching standard service or taking the fee more than the determined amount or any delay of the provision of public services over the determined maximum period, etc.

- **Article 3:** The General Department of Customs and Excise of Cambodia shall determine a specific location and have standby official(s) with one-stop characteristics at the determined location, in order to serve the public on time by the due date. In the meantime, the General Department of Customs and Excise of Cambodia shall strengthen and enlarge the automated system to provide public service in a more convenient, transparent and effective manner.
- Article 4: All direct collections of revenues in cash or by cheque from public service fees as stipulated in the annex table attached to this Prakas shall be accompanied by payment receipts issued by the General Department of State Property and Non-Tax Revenue of the Ministry of Economy and Finance in compliance with Prakas No. 272 SHV.BRK dated 17 March 2011 on the Implementation of Payment Receipts and Circular No. 005 SHV dated 17 March 2011 on the Management of Payment Receipts of the Ministry of Economy and Finance unless revenues allowed to be collected through the Automated System for Customs Data.
- **Article 5:** The General Department of Customs and Excise of Cambodia shall prepare annual budget revenue plan with the basis of planning specific revenues and detailed revenues plan as per each public service type.

Upon the implementation of revenues, the General Department of Customs

and Excise of Cambodia shall be responsible for the collected revenues, paying revenues and transferring them to the national budget, in which it shall register in the accounting record regarding the revenue transactions, and record to monitor the revenues in the chapter, account, sub-account of the budget contents.

- Article 6: The General Department of Customs and Excise of Cambodia shall prepare situational reports on the implementation of monthly and annual revenues for the Minister of the Ministry of Economy and Finance prior to the 10th day of the following month for the monthly report, prior to the 15th day of January of the following year for the annual report. This report shall be forwarded to the General Department of State Property and Non-Tax Revenue to monitor the implementation of revenues.
- **Article 7:** The public service list as stipulated in the annex table attached to this Prakas may be amended by a Prakas of the Minister of the Ministry of Economy and Finance, if necessary.
- Article 8: Prakas No. 1151 SHV.BRK dated 15 September 2015 on the Provision of Public Services of the General Department of Customs and Excise of Cambodia of the Ministry of Economy and Finance was abrogated.

Any provisions contrary to this Prakas shall be null and void.

Article 9: All Cabinet Chiefs, Secretaries General, Delegate of the Royal Government in charge as General Directors, Inspectors General, Department Chiefs, Directors of Departments and Chiefs of Relevant Units under the supervision of the Ministry of Economy and Finance shall be in charge of respectively implementing this Prakas from 01 January, 2019 onwards.
